# How to Pay

The method of payment for donations is online, through bank or by credit card. We do not capture or store your credit card details, only the authority from our secure payment provider, Mollie the Netherlands, that your credit card payment has been approved. We accept Visa and MasterCard via a secure payments system which is linked directly to our secure payment provider who will authorise all credit card payments. We can accept cards issued in Europe or overseas however all payments are processed in Euros. You will receive a receipt with a copy of the payment information received for each donation.

# **Refunds and cancellations**

If you make an error in your donation a refund may be available. Any refunds will be made by credit to the card used for the original purchase or donation. If you make an error please, email donations@jacana.help immediately. Donations cannot be cancelled after 7 working days.

# **Privacy policy**

Jacana collects information on this website in order to record and process donations for Jacana projects and programs. All information collected is processed in accordance with the National Privacy Principles. The information provided by you during the donation process and any other information sent to us by you or otherwise obtained by us about you is only used for the purposes of donation and informing you about project status; and issuing a receipt. Credit card information is collected and processed by our secure payment provider Mollie in the Netherlands on behalf of Jacana. Your credit card details are not saved during the donation process nor are they in any way viewable or accessible by Jacana staff or any other parties. The information you provide is stored and used only for the purpose of processing your donation. If you do not wish your personal information to be handled in this way, you may cancel the donation process. ## How do we protect your information?

Our website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our site as safe as possible.

We use regular Malware Scanning.

Your personal information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the information confidential. In addition, all sensitive/credit information you supply is encrypted via Secure Socket Layer (SSL) technology.

We implement a variety of security measures when a user enters, submits, or accesses their information to maintain the safety of your personal information.

All transactions are processed through a gateway provider and are not stored or processed on our servers.

# Do we use 'cookies'?

We do not use cookies for tracking purposes

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser settings. Since browser is a little different, look at your browser's Help Menu to learn the correct way to modify your cookies.

#### **COPPA (Children Online Privacy Protection Act)**

#### **Fair Information Practices**

The Fair Information Practices Principles form the backbone of privacy law in the United States and the concepts they include have played a significant role in the development of data protection laws around the globe. We will notify you via email

• Within 7 business days

We also agree to the Individual Redress Principle which requires that individuals have the right to legally pursue enforceable rights against data collectors and processors who fail to adhere to the law. This principle requires not only that individuals have enforceable rights against data users, but also that individuals have recourse to courts or government agencies to investigate and/or prosecute non-compliance by data processors.

## CAN SPAM Act

The CAN-SPAM Act is a law that sets the rules for commercial email, establishes requirements for commercial messages, gives recipients the right to have emails stopped from being sent to them, and spells out tough penalties for violations.

## We collect your email address in order to:

• Market to our mailing list or continue to send emails to our clients after the original transaction has occurred.

## To be in accordance with CANSPAM, we agree to the following:

- Not use false or misleading subjects or email addresses.
- Identify the message as an advertisement in some reasonable way.
- Include the physical address of our business or site headquarters.
- Monitor third-party email marketing services for compliance, if one is used.
- Honor opt-out/unsubscribe requests quickly.
- Allow users to unsubscribe by using the link at the bottom of each email.
